New MCCA Entry Sign Initiative

MCCA began a program to replace entry signs some time ago, starting with the Cypress and Magnolia divisions. This fiscal year we've replaced signs along Mill Creek Blvd, Trillium, and the north end of Village Green Drive. **Beginning in July, we will continue with new entry signs** in Red Cedar, and again continue down Village Green Drive until the 2021-2022 budget for new signs is exhausted.

MCCA Maintenance Effort

As our weather improves our maintenance effort shifts into high gear. **This is an extremely busy time** for our crew members. We are trimming, mowing, cutting back vegetation, watering hanging baskets, checking on all of our irrigation systems, and making the Association amenities ready for summer activities.

Assessment Invoices

ADMINISTRATION

Summer is almost here and we are looking forward to everything that the season brings. We sent out the assessment notices at the end of May. Many of you received the email notification and have paid already. Thank you for your prompt payment! Please note that the paper version of the invoice is automatically mailed out at the same time, but will take longer to arrive at your mail box. If you have already made your payment, please ignore the paper invoice you will receive in the mail.

We are planning for a busy summer. This is the time of the year when we dig into some major projects. This summer we have plans to:

- Work on our retention ponds, with special emphasis on Holly, Cherry, and Chatham East ponds.
- Replace broken asphalt trail sections within the Nature Preserve.
- Continue the entry sign upgrade project.
- Resurface the sport court in Big Rock Park (Evergreen).

In mid-June volunteers will start handing out the **Beautiful Yard Awards**. There is still time to get your yards ready for judging. Our volunteers make every effort to pick a new yard in every division each year. The list of winners will be published on the MCCA website after all awards are distributed.

MAINTENANCE

We are onboarding our seasonal crew members and getting ready to tackle some of the larger landscape projects in the Association. Mowing season is in full swing and everything is growing. The vegetation around our seven retention ponds has also grown and crews will address that in June. We have also noticed that some entry plantings are outgrowing their spots; we will begin editing later in the summer so we can be ready to plant in the fall. Irrigation at all entries is on and set to water three days per week at 4 am. If you notice an issue with the irrigation at your entry, please contact the MCCA office.

SECURITY

Both Security and the office have received calls from residents who are noticing an uptick in door to door sales calls in the area. MCCA covenants pertain to homeowners within MCCA only, so we do not have rules that we can enforce against door to door sales. However, the City of Mill Creek's Municipal Code (Chapter 5.08 Solicitors and Peddlers) does provide rules for peddling and soliciting. Please refer to the [city website](#) for more information.

It is a good idea to take a cell phone with you on your walk or jog. In May Security helped two residents who required assistance while on the trails or sidewalks. One resident fell and was pretty scratched up, while the other had a medical emergency and Security was able to call an ambulance for help. Bring your cell phone with you and make sure you have the Security number (425-328-0035) saved in your contacts. We are just a call away!

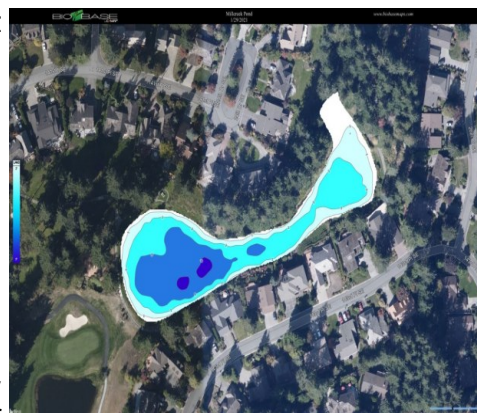

CHERRY POND

In January, the MCCA Board of Directors engaged [Aquatechnex](#) to report on the condition of Cherry Pond. The Board had concerns about the annual algae blooms, pondweeds, and sediment accumulation and looked for an expert opinion on how to handle these issues. Aquatechnex suggested performing a hydroacoustic mapping mission to understand the conditions of the pond, such as the depth and composition of the sediment.

The Challenge

Aquatechnex found the surface of Cherry Pond to be 1.9 acres, and calculated the volume of water stored at 4.31-acre feet. The Bathymetry Map shows the depth of the pond. The darkest blue spots are a depth of four feet; the majority of the pond is in the lighter blue shades, representing a depth of 2-3 feet. A shallow pond means that sunlight reaches the pond floor and provides an ideal habitat for the growth of filamentous algae.

The study also found that most sediment in the pond is an accumulation of very fine organic material. Dredging is one way to remove sediments and improve the pond; however, conventional dredging requires constructing a dewatering area capable of receiving the entire volume of sediment to be removed. This area is either a constructed pond where the sediment is pumped, dried, and removed over time or a geo-bag that fills a similar role. There is no space for a sediment pond or geo-bag within Cherry Park. A further issue is that the cost of dredging, especially disposal of the waste, is enormous.

The Solution

A combination of two technologies addresses the algae and organic sediment accumulation; improving the water quality of Cherry Pond. The first technology is a [nanobubble system](#), and the second is regular applications of [MuckBiotics](#) pellets.

A [Moleaer 50 CLEAR nanobubble generator](#) is an electrically powered device installed on the shore of the pond. The unit is about the size of a large suitcase and runs quieter than the pumps powering the fountain. The cost of this solution is a fraction of the cost of conventional dredging. The unit pumps water from the pond through a nanobubble generator that discharges the nanobubble-laden water back into the pond. Nanobubbles are microscopic, they do not float as they are too small to be buoyant, and they disperse throughout the pond. Nanobubbles attract and attach to pond sediments and burst. When they burst, they deliver oxygen directly to the lake sediments, which speeds up the rate of decomposition. The nanobubbles also help to control algae by oxidizing the algae cell.

MuckBiotics pellets treat an entire body of water from the bottom up. These small tablets are broadcast over the water's surface and sink to the bottom. They deliver a combination of bacteria and enzymes that speed the digestion of accumulated organic sediments.

We talked with current customers in California and visited an installation at the Glendale Country Club in Bellevue, WA. Everyone we spoke with was thrilled with their water quality after installing the nanobubble machine. The Board decided that this is an excellent solution to improve the conditions of Cherry Pond and ordered a nanobubble generator. We look forward to installing the machine this summer to provide a healthy environment for the many ducks and aquatic animals that call Cherry Pond home and maintain Cherry Pond as both a functioning retention pond and beautiful landmark.

Storing Household Items

When spring approached, I noticed many waste and recycle containers were being stored in view. I also saw other items that are in view and would like to connect on those items here. As stated in your restrictive covenants, the following items must stored out of view:

- Cordwood
- Debris stored until disposal
- Lawnmowers and other mechanical equipment
- Ladders
- Pots
- Toys and playground equipment
- Project supplies over time bricks, soil, bark
- Disposed of items
- Heat pumps and A/C units
- Mechanical equipment (for solar devices, hot tubs, pools)

Please take a walk outside your home and ensure that any stored items are not visible from the street and neighboring properties. If you can see items from the road or trail, then this would mean you need to find a more suitable storage place either in your garage or behind a fence.

When working on a big landscape project, it is tempting to leave your tools and equipment out so you can get right back to work the next day; however, this clutter can be unsightly for your neighbors, especially if the project timeline stretches. So ask yourself, "am I going to get those garden beds done this weekend?" or "am I going to finish that retaining wall this week?" If not, then store the items out of view until you can get to the project.

Hazardous Waste

Summer is a great time of year to go through the garage and get rid of old tools, equipment, and supplies you no longer need. If you have items that you want to get rid of or dispose of, please place those items out of view until the day before garbage and recycle pickup. Bring household hazardous waste to the appropriate facility for safe disposal. Consult the [Household Hazardous Waste](#) page of the Snohomish County website for information on safe household hazardous waste disposal.

Screening Mechanical Equipment

Mechanical equipment, heat pumps, and A/C units are to be aesthetically concealed. "Aesthetically concealed" means screening the equipment with plants, a fence, or a decorative lattice. If you need suggestions about how to screen your equipment, please reach out. I have many ideas and would love to give you some inspiration.

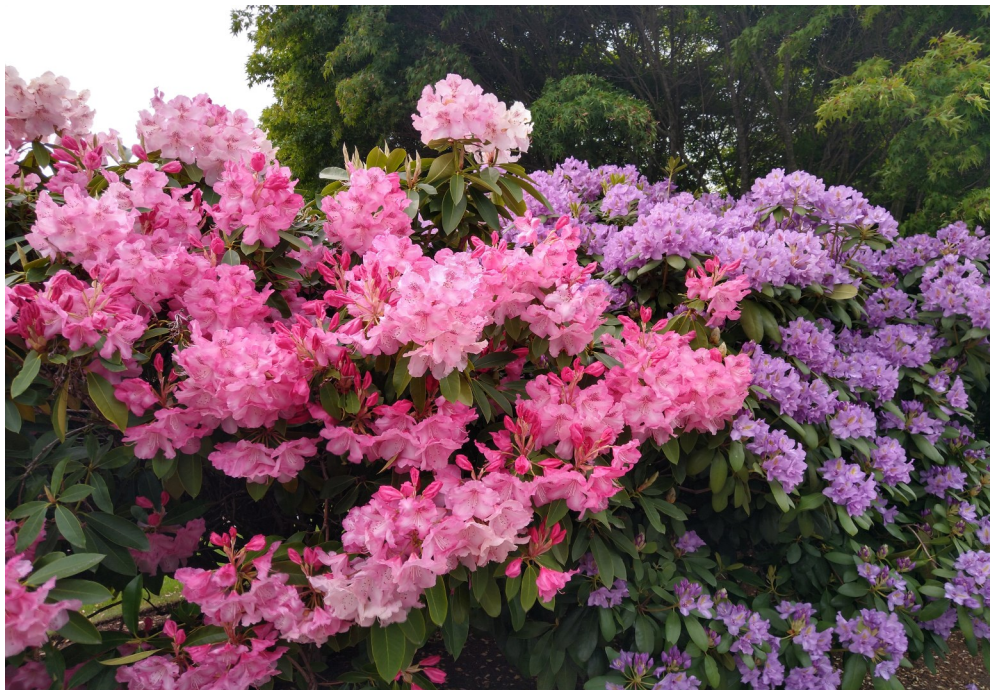

ARCHITECTURAL CONTROL COMMITTEE

Exterior Painting

We have recently seen some neighbors using the same painting company for exterior painting projects. This is an excellent idea because you may all benefit from a lower cost. Most painting contractors are not aware that our guidelines state your home must be a different color than your neighbor's. Please communicate with your neighbors to check that you haven't chosen the same or almost the same color. Once your colors are determined, submit your applications to the office with your paint swatches. Have your large paint sample ready at the front of your home when you apply. You can paint your three foot by three foot swatch directly on your home, or on posterboard and tape it to the front of your home. It is a good idea to apply at least two weeks before your painter wants to start. This allows us to process your application efficiently and avoids any conflicts with your painter's schedule. Most painters will move on to the next project if you are not ready to go with your chosen paint color, approved by the Architectural Control Committee (ACC), on the day they want to start.

Fence Projects

The old saying, "good fences make good neighbors," has its merits. However, fences can cause tension among neighbors when someone is surprised by a fence project. Before you start your fence project, please talk with your neighbor and discuss the location and type of fence you are proposing.

It is the homeowner's responsibility to know their property lines. Generally, property lines are marked with a piece of rebar stuck into the ground at each corner. Over time, these markers can disappear or get covered with debris and soil. If that happens, you can use the plat maps on the city website to measure your property line and get a fair idea of where they are. To get an exact idea, you will need to engage the services of a surveyor, which can cost a few thousand dollars. If you and your neighbor can agree on the property line before starting your fence project, you could save some money.

The next thing to discuss with your neighbor is the style and finish of the fence. Our guidelines state that the good side of the fence must face the road and adjacent properties. If you are paying for the fence, you might want to choose a style that looks good on both sides. Once your fence is up, a good quality stain ensures that it will last. Again, it is a good idea to consult with your neighbor on the color, and don't forget to get that stain color approved by the ACC as well!

Taking a bit of time in the beginning to talk with your neighbor can save you a lot of grief. MCCA thanks you for taking that extra step to ensure that MCCA is a beautiful and peaceful place to live!

NOXIOUS WEED COMMITTEE

THANK YOU! to the gentleman that stopped by the corner of Village Green Drive and 148th Street SE where the Noxious Weed Committee (NWC) was working on Monday, May 3, and handed the NWC an envelope stating, "Thank you for your service as we move through this pandemic with kindness, compassion and gratitude" and stated lunch for the volunteers was on him! Thanks to your generosity, the NWC will be enjoying a get-together cookout in the near future!

Spring was an extraordinarily busy time for the NWC when plants purchased by MCCA from the Snohomish Conservation District were placed in areas undergoing native plant restoration, and in new areas cleared by the MCCA Maintenance Team and the NWC. Bald hip roses, blanket flower, Oregon sunshine, ocean spray, red elderberry, red flowering currant along with some beaked hazelnut, sitka spruce, and vine maples were planted; and all are thriving! You may see some with temporary caging to protect them from our resident rabbits and mountain beavers!.

The NWC would like to remind residents to please contain your choice of ground cover within your property. The NWC is finding vinca major and vinca minor, also known as periwinkle, showing up more and more in our common areas, forming a thick mat and suffocating our native plants..

One of the larger undertakings by the NWC this spring was to begin restoration of North Park within the Vine Maple subdivision. The MCCA Maintenance Team cleared out dead trees and blackberries. Enter the NWC to haul out resident debris that had accumulated over the years and to remove the blackberry crowns and other noxious weeds. Sheet mulching was done in some of the area, and sword ferns and a variety of trees were planted. The area is a work in progress!

Crosswalk Reminder

The Trail Ambassadors have noticed that many motorists are not stopping for pedestrians at crosswalks. Please be aware that there is a crosswalk at EVERY intersection under Washington State law, whether marked or unmarked. Please remember that at some point in the day, we are all pedestrians. Be sure to use caution when driving our roads and be ready to stop for pedestrians using crosswalks. You can find more rules of the road in the [Washington State Driver Guide](#).

Pedestrian Laws

Washington State also has rules for pedestrians. The Governor's Highway and Safety Association noted that pedestrian fatalities were on the rise in 2020. With more people out walking during the pandemic, it is good time to freshen up on these rules. The following is a summary of [Washington State pedestrian laws](#) from the Washington State Department of Transportation website.

- **Traffic signals** - Pedestrians must obey traffic signals and traffic control devices unless otherwise directed by a traffic or police officer ([RCW 46.61.050](#)).
- **Sidewalks** - Drivers and bicyclists must yield to pedestrians on sidewalks and in crosswalks ([RCW 46.61.261](#)).
- **Pedestrians on roadways** - Pedestrians must use sidewalks when they are available. If sidewalks are not available, pedestrians must walk on the left side of the street, or its shoulder, facing traffic ([RCW 46.61.250](#)).
- **Moving into traffic** - No pedestrian or bicycle shall suddenly leave a curb and move into traffic so that the driver can not stop ([RCW 46.61.235](#)).
- **Drivers exercise due care** - Every vehicle driver shall exercise due care to avoid colliding with any pedestrian upon any roadway and shall give a warning by sounding the horn when necessary ([RCW 46.61.245](#)).
- **Stop for pedestrians at intersections** - Drivers shall stop at intersections to allow pedestrians and bicycles to cross the road within a marked or unmarked crosswalk ([RCW 46.61.235](#)). See Washington's Crosswalk Law for more information.
- **Yield to vehicles outside intersections** - Every pedestrian crossing a roadway at any point other than within a marked crosswalk, or within an unmarked crosswalk at an intersection, shall yield the right of way to all vehicles upon the roadway ([RCW 46.61.240](#)).

Let's work together to share the road and keep both drivers and pedestrians safe!

PARKING SAFETY REMINDER

Please remember to use caution when parking your car along the road or in parking lots, including the parking lot in Chopper Park. Make sure your vehicle is locked, and never leave valuables in your car! The safest place to park your vehicle at night is always in a locked garage. If you notice someone walking along who seems to be checking car doors or looking into car windows, please call 911 and report the suspicious activity to the Mill Creek Police Department. Remember, this type of crime can happen during the day, so always be on alert.

BLOCK WATCH—CITY OF MILL CREEK

In May, Larissa Pigott, Police Support Officer, joined the MCCA Sub-Association meeting to talk with our Condo and Townhome boards about the Block Watch Program. The Block Watch Program can help improve our neighborhoods' safety by bringing neighbors together to watch out for each other and report suspicious activity and in-progress crimes to 911. Police Support Officer Pigott also provided this helpful list of suspicious activities that warrant a 911 call.

- Sounds of fighting, screaming, gunshots;
- People peering into parked vehicles that are not theirs; trying to open doors of vehicles;
- A person removing accessories or vehicle's parts (cutting catalytic converters in Toyota Prius vehicles are on the rise), also removing license plates or gas;
- Noises of breaking glass; a beam from flashlight in a neighbor's home, when the neighbors are away;
- Open or broken doors or windows at a home;
- Vehicles driving slowly and multiple times through a neighborhood; casing a home;
- A vehicle driving behind a UPS or delivery trucks and collecting parcels from residences (Please try to get a vehicle's plate number, or a make, model, and color of the vehicle);
- A person going around a residence and peering into windows, going into a back yard, checking a front door lock or a garage door;
- A person claiming to represent a utility company, but not wearing a uniform, does not produce an ID upon request or does not have a company logo on a vehicle;
- A person sitting in a vehicle for long periods and conducting transactions from a vehicle;
- A person exhibiting unusual mental or physical symptoms (request for a welfare check is appropriate);
- A person carrying property and attempting to hide it in the bushes;
- Abandoned vehicles which can be stolen vehicles or used during a crime.

Reserve Library Materials

Use our catalog, books, and movie pages to browse the 1.6 million items available to you. Then, use your library card to place items on hold or checkout available digital resources. When your items are ready, you will receive an automated email and/or phone call.

Holds Pick Up

1. Come to the library where your items are on hold.
2. When you get here, call the pickup-notification number for the library. The Mill Creek Library pickup number is (360) 651-7189.
3. A library staff member will ask for your name or library card number.
4. A library staff member will then meet you at the library's main door.
5. Before opening the door, the staff member will verify your identity by name or library card number.
6. You will be asked to step back from the closed door.
7. The staff member will place your items outside the door in a recyclable paper bag labeled for you.
8. Take home and enjoy!
