As an Association member, a portion of your annual assessment goes to support the MCCA Security patrols. Have you wondered what our Security team does? I am happy to report that the team we have, headed by Supervisor Lois Dawkins, does a tremendous job. In addition to their security duties, they assist members, call homeowners when garage doors are left open after dark, and pick up and return packages as part of our vacation check service. Any suspicious activity or accidents are reported to our local police department. The statistics below are the final numbers for the fiscal year July 1, 2021, through June 30, 2022.

Doggy "Doo" and Don'ts

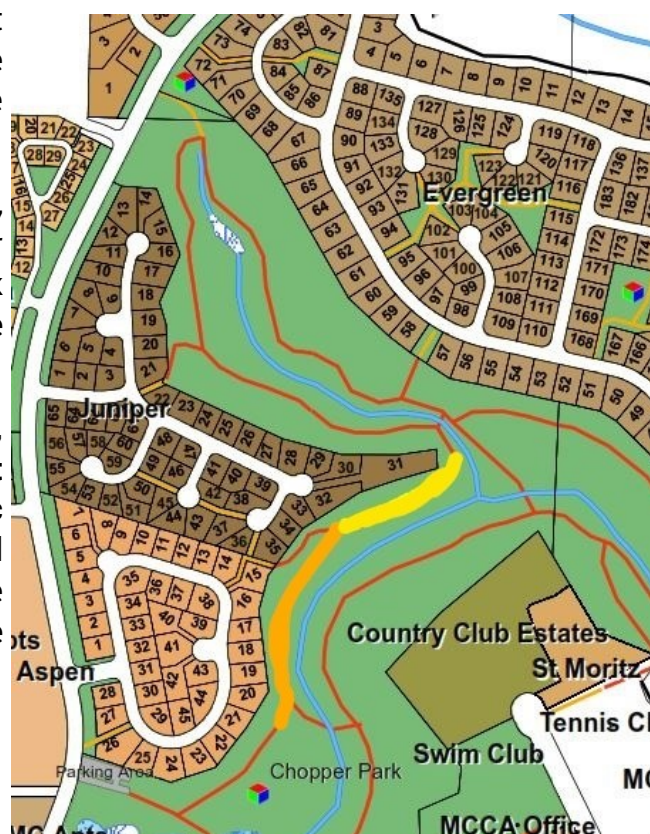

Nature Preserve Trail Closures—August 25 through September 2

The Board of Directors is moving forward with plans to replace damaged trails in the Nature Preserve. This year we are focusing our efforts on a section of trail behind the Juniper division. On the map below, the yellow section marks the trail that is being replaced. The orange section marks the portion of trail our vendor, Benjamin Asphalt, will use for access.

August 29 through September 2, Benjamin Asphalt, will stage equipment at the north end of Chopper Park. Please use extra caution in the park that week as large trucks will be entering and exiting during the day.

Both sections of trail marked in yellow and orange, from the north end of Chopper Park to the northeast tip of the Juniper division will be closed to all traffic August 29 through September 2. Please be respectful of the posted signs and plan your travel through the Nature Preserve accordingly. Thank you in advance for your cooperation.

4. When the Account page opens, select "Notifications" from the options along the top of the page.
5. On the Notifications window, select "Change my settings" if you have not opted-in before, or "Update mail settings" if you have already opted-in and wish to make a change.
6. Click the 'I Agree' blue button.
7. If you wish, you can select "Print my opt-in agreement" to get a paper copy of your opt-in agreement.

Shift Increase and Openings

We have increased security hours to 20 hours per day with two drivers per day working a ten hour shift. We have openings for part-time fill-in drivers who are willing to help us cover shifts when drivers are out sick or on vacation. We are looking for someone who can cover the morning or evening shift as needed.

New Security Staff

We have several new security drivers. Please feel free to flag us down and get acquainted. We now have two vehicles in service for security. We are using the RAV4 as well as the Prius. We remind you if you see something odd, please call 911 if it seems urgent or the non-emergency police number. Always call security after you make your police report so we can also be aware of what is going on. No reporting crime or suspicious activity is never a good idea. We all need to do our part to keep our neighborhoods safe.

Garage Door Reminder

Our increase in patrol hours allows us to catch many more open garage doors. We do our best to catch all open garage doors, and request that you help us keep MCCA safe by remembering to check that your garage doors are closed and secure. Please keep the office updated with your current phone number so we can call you about your garage door when we see it open.

There is a video circulating on social media of a person walking past an open garage door in the midafternoon. The person looks over and sees a bicycle hanging up in the garage. It takes only 7 seconds for this person to enter the garage, get the bike off the hanger and steal it. This incident did not happen within MCCA; however, if it can happen in another HOA, it can certainly happen here as well.

Spring Projects

My summer is busy with questions and guidance on ACC and Covenant issues. Please remember that MCCA requires residents to apply for exterior changes, and not applying can be costly. If you have questions, the MCCA office staff is just an email or phone call away. Please do not hesitate to contact us by email info@mcca.info or by phone (425)316-3344, we look forward to working with you.

Political Signage

Some residents mistakenly say that political signs are not allowed in MCCA. This is not true; due to state law, "HOA's may not prohibit political signs." The state allows HOAs to adopt reasonable rules regarding political signs, and the MCCA Board of Directors did this on July 20, 2005 and it is published on page 12 of the Covenant Guidelines.

We are in a big election year and the Primaries are on August 2, 2022, followed by the General election on November 8, 2022. This is a great time to review the MCCA policy for political signs. The [MCCA Declaration of Restrictive Covenants](#) Article VII, Section 7.13.2 Signs states:

Owners may display political yard signs regarding candidates for public or Association office, or ballot issues, on or within a Lot or Living Unit subject to rules adopted by the Board governing the time, place, size, number, and manner of those displays. Owners may erect temporary signs, not to exceed four (4) square feet, advertising a home for sale. Nothing herein shall be deemed to prohibit reasonable and tasteful house numbers for addresses, or occupants' names on mailboxes. No business signs, advertising signs, or signs in any way relating to services, occupation or profession are allowed. Signs posted in violation of this provision may be removed upon order of the Board following Notice and Opportunity to be Heard. The Board may adopt rules regarding signs for security systems, political signs, for sale signs, service provider signs, and any other type of sign.

MCCA's current policy on political signs ([Covenant Guidelines](#), page 12) states:

*Political yard signs are allowed **60 days before** and **three days following** a general or primary election. The sign must be placed a minimum of 20 feet from the street, and the height may not be more than 4 feet above the ground. The total sign area for an individual residence may not exceed 6 square feet.*

2022 MCCA allowed dates for political signage:

- **August 6, 2022**—political signs must be removed.
- **September 9, 2022**—political signs for the general election may be posted.
- **November 12, 2022**—political signs must be removed.

While MCCA has some of the most dedicated volunteers for an HOA, Covenants are not the easiest. With that, I would like to take this opportunity to thank all the volunteers on the MCCA Covenant Committee for their hard work and dedication to working with the residents of Mill Creek Community Association. ARCHITECTURAL CONTROL COMMITTEE

This Old Driveway

Being part of a large community governed by a homeowner's association has benefits and comes with responsibility. The Association is responsible for providing well-maintained common areas and monitoring cohesive aesthetics in the neighborhoods to maintain property values. To do that, MCCA asks individual property owners to play their part. MCCA has an approval system that helps ensure all exterior changes to homeowner properties are within guidelines and will fit the cohesive aesthetic that keeps our neighborhoods in good-looking order.

As properties age, there are big ticket exterior items that must be addressed. Exterior Paint, Roof, and Driveway Replacements are samples. While unattended roof and paint may cause significant damage to the home and the driveway may not – driveway replacements are no less critical to fulfilling homeowner requirement to keep properties in good, maintained order.

At 40+ years of age, our neighborhoods are seeing their share of cracked driveways that need attention. There are cases when a driveway can be repaired by slab lifting, but in most cases, extensively cracked or sunken driveways need to be replaced. Stop-gap measures such as crack filling and painting most often leave the property looking worse than before the intended "fix." The MCCA has seen very few attempts to apply paints or coatings to driveways but cautions that these "fixes" are changes to the exterior, and homeowners must apply for permission.

MCCA currently allows concrete or paver driveways. Asphalt or asphalt tar type coatings do not fit the aesthetics, are not allowed. If you are moved to make a quick fix to your driveway because you feel it is in less than attractive shape, consider replacement before any quick fix coating. MCCA's current position is that coatings for cracks and unremovable stains are not allowed on driveways.

All exterior changes to your property require approval from the MCCA Architectural Control Committee. Please apply for your external changes and if you have any questions, contact the office.

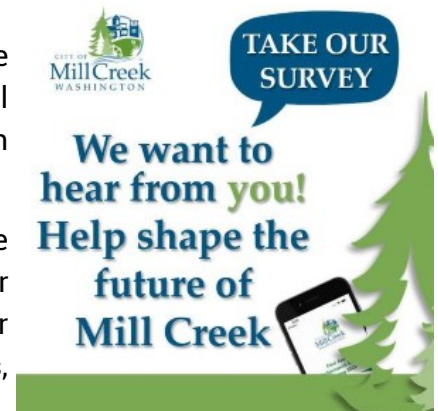
MESSAGE FROM THE CITY OF MILL CREEK

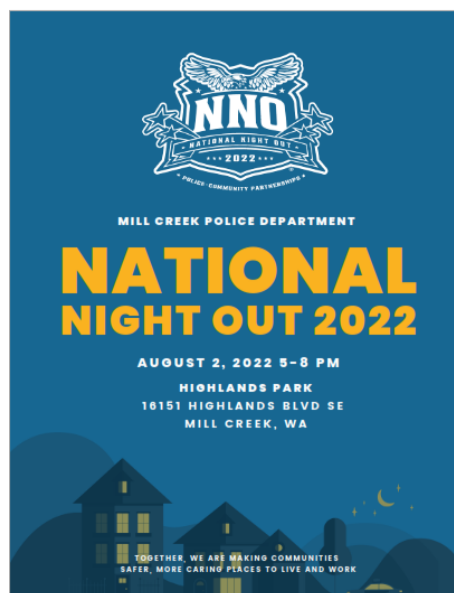

Mother Hummingbird Nests above Nature Walk

Hey birders, now is a great time to visit the Adopt A Stream Foundation's Northwest Stream Center located at the south end of Snohomish County's McCollum Park, 600 - 128th Street SE, Everett WA 98208. Bring your binoculars and bird sound apps

Last week, Adopt A Stream Foundation (AASF) member, Michelle Forquer, captured an image of a mother hummingbird on a nest. That nest is on a cedar branch above the Northwest Stream Center's *Elevated Forest and Wetland Walk*.

Hummingbird eggs are about the size of coffee beans. Most females lay two eggs, which they incubate for 15 to 18 days. Juvenile hummingbirds fledge (leave the nest) 18 to 28 days after hatching. So, you have a couple more weeks to check out this nest before the babies take flight.

Last night, I was on the hunt to find that nest," says Adopt A Stream Foundation Director Tom Murdoch. "My bird sound app identified 16 different birds species in the 1/2 mile walk. The nest was so well hidden, it was tough to find even though I had GPS coordinates"

Go to www.streamkeeper.org or call 425-316-8592 to reserve a time slot Tuesdays through Saturdays 10am to 4pm. No more than 5 visitors each 15 minutes. Please bring a mask as they are required inside the Nature Store exit.

Sorry, no dogs allowed at the Northwest Stream Center except coyotes. Also, anyone under 18 has to be accompanied by a responsible adult.

The Northwest Stream Center is the result of a partnership between the Adopt A Stream Foundation and the Parks Division of Snohomish County's Department of Conservation and Natural Resources.

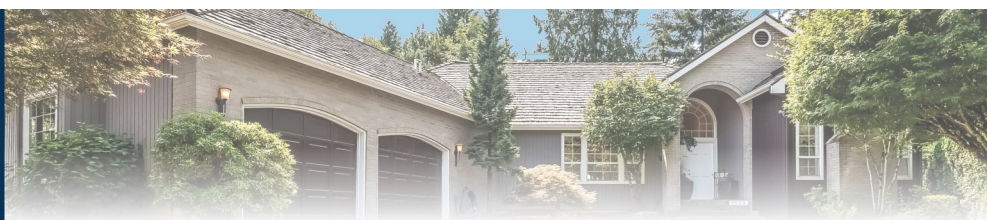
