Elections are upon us – not only for your national and state leaders but also for your homeowner's association. MCCA Board elections take place each fall. There are four board seats to fill in even numbered years, and three seats to fill in odd numbered years. This year, the Nominating Committee has approved five candidates for the ballot. We have five people running for the four available board seats which means we have a contested election. The four candidates with the most votes will win. Please give thoughtful consideration to the volunteers willing to put their names forward to serve the Association and note that you can vote for four different candidates (cumulative voting is not allowed). Three candidates are returning board members; two are newcomers with previous MCCA experience. Residents may join us at the MCCA office for a **Meet the Candidates open house on Wednesday, August 21, from 4 pm to 5 pm** after our regularly scheduled board meeting. Please vote on or before the MCCA annual meeting on September 25, which will be held online at 7 pm. Please check your email and the MCCA calendar for the link to join. Voting packets will be mailed or emailed out to members later this month.

The board, staff, committee members, and community extend a big "thank you" to Becky Edy, who served many years on the Architectural Control Committee (ACC), and chaired that committee for two years. Becky has served on the board for two years, this last year as secretary, and chaired the Nominating Committee this year. Becky is now moving on to pursue travel and other interests with her husband Bill. We thank Becky for her service to the community and wish her well!

Speaking of the other elections, be sure to observe the guidelines for posting political signs as described in our <u>Rules and Regulations</u> document on the Resident Resources page of the <u>MCCA website</u>.

Our ACC plays a pivotal role in maintaining the high standards of our neighborhoods. In response to the numerous questions about outdoor lighting, the ACC has thoughtfully updated the <u>Rules and Regulations</u>. These updates address the evolving needs for lighting, both decorative and for security and safety reasons. Extensive discussions with the ACC and Covenant Committee resulted in these updates, which the Board adopted at the June meeting. It will define the standards we will enforce starting at the end of the year, providing residents with time to familiarize themselves with the new rules and come into compliance.

Opt-In to Electronic Notifications

MCCA will soon mail out the Annual Meeting elections packet. Please help us save on mailing costs and reduce our environmental impact by opting-in to electronic communications. It is now easier than ever!

MCCA Assessment Payments Were Due July 1!

The MCCA Board extends a 30 day grace period for assessment payment in July. Per our <u>Collections Policy</u>, a late fee of \$25 is assessed to accounts with outstanding balances on August 1. We thank the many members who have already paid the 2024/2025 assessment. Thank you for being so prompt! Invoices were mailed out to all single family home residents in late May. If you have not received your invoice, please contact the MCCA office (<u>info@mcca.info</u>) and we are happy to send you a copy. For our townhome and condominium residents, your sub-association board receives the invoice and pays your annual MCCA assessment on your behalf. Some sub-association boards include the MCCA assessment in the monthly dues, other boards collect the MCCA assessment separately from their residents.

If it is easier for you to make several smaller payments over the year rather than one large payment, we allow that option. You can always make several smaller payments in advance, and now is a great time to start. You can prepay the 2025/2026 annual assessment with as many smaller payments as you would like. We have many residents who use their bank's bill pay service to set up recurring payments as prepayments to next year's assessment. Please note, you cannot set up regular prepayments in PayHOA.


Does Mill Creek have a Scoop Law?

Yes! The City of Mill Creek has a Scoop Law as described by <u>Municipal Code</u> <u>6.14.010</u>. The law requires all persons walking dogs away from their premises to carry a bag of sufficient size to pick up fecal matter deposited by their dog.

Disposing of those bags on the ground as shown in the photo here is not the proper way to dispose of pet waste! Please carry waste bags to nearest trash can. We have 21 handy trash can locations throughout our Association and they are marked in pink on the map below. The locations are dispersed throughout the Association in areas that are easy to use, and easy for our maintenance crew to service.

Tree Work

MCCA has our arborist, Sal Noeldner, come out to assess trees in the common areas several times during the year. Sal's latest visit in late June has kicked off a few projects we hope to complete in August or September. The first project is the removal of a large Cottonwood tree in North Park, Vine Maple. This tree is surrounded by homes and is starting to lose scaffolding branches. The many holes in the bark show that the sap suckers are hard at work on this tree, which is another sign that the tree is under stress. Sal anticipates more limbs will be lost as the tree is weakening. In a forest situation, it would be acceptable to let nature take its course. When a tree is located in the middle of a group of homes, mitigating risk of damage to property and persons must take priority. Sal has recommended removal of this tree, and the Board voted in June to follow his recommendation.

The second project is at the Juniper entrance, on the left side as you enter from Mill Creek Boulevard. This entrance is symmetrical with a large brick wall and signs on both side. The wall on the left side has sustained damage as the roots of the large trees behind it are pushing it out of alignment. This damage was first noted about three years ago and we tried to ease pressure on the wall by removing the dirt behind it, and adding drainage rock and weep holes to give water built up behind the wall a way to escape. Unfortunately, that did not remedy the issue and the wall continues to move. Sal's observations indicate the large Douglas Fir tree on the left side has a substantial root system that is pushing on the wall. Moving the wall would buy some time, but would not solve the issue, and the expense of removing and rebuilding the wall is substantial.

With an eye to keeping costs under control, the board voted to remove this Douglas fir tree. To ensure the root system of the tree does not continue to move the wall, our crews will do some plunge cuts in the stump and pack it with salt to dry it out and ensure the roots stop growing. Once the tree is gone, we will monitor this wall to see if it settles and stops moving.

Flower Baskets

This year we have had two of our flower baskets stolen. Our maintenance crew will not be removing baskets until mid-September, depending on the weather. If you see someone attempting to take down a basket on the weekends or in the evenings, please call Security immediately (425-328-0035).

Nature Preserve Drain Work

Drain 8 is located on the trail that backs to the hillside behind Country Club Estates. This drain is clogged and crews are working to get the water flowing again. It is amazing to see how much water comes off the hillside in late July. Crews have managed a temporary fix and we are working on a fix that will keep the water flowing properly all year long.

Cherry Park: Pipe Replacement Project

Last year, we replaced the leaking catch basin that maintains the pond level at the Cherry Park retention pond and cleared out decades of sediment.



This year, we discovered that the pipes leading from the new catch basin to the golf course pond were also leaking. Understanding the importance of this issue, we have decided to replace them. Both a 12" and 18" pipe lead from the new catch basin to the golf course. As these pipes are the same age and located on top of each other, we are replacing both to the end of our property line, where we will connect them to the pipes that continue to the golf course pond. Currie Construction did an excellent job cleaning out the pond last year and will return to Cherry Park for this crucial project. We need to lower the water level of the retention pond to dry out the ground around the catch basin. The scheduled start date for the project is August 5.

The concrete path from the Huckleberry division between the retention pond and golf course is the main access to the park for all our maintenance tasks. This path sustained some damage last summer when the retention pond was cleaned, and we anticipate some more damage due to the pipe replacement project. When this project is complete, we will work on replacing that section of the path with a concrete path built to withstand better the types of heavy maintenance vehicles occasionally required to enter the park.

Critter Corridor

As you drive along the north end of Village Green Drive, you may have noticed we've begun clearing the large triangle-shaped common area between lots 77 and 78. This space was overgrown with Himalayan blackberries, invasive plants, dumped landscape debris and garbage. Our goal is to clear the area of brush and debris and provide a safe forage area for small critters like birds, squirrels, and pollinators.

The Noxious Weed Committee is busy removing weeds and spreading wood chips. We look forward to planting this area in the fall. Specific forage plants like cascara, red flowering currant, and a Garry oak will be planted in fall 2024. Having an environmentally themed purpose that's beneficial to animals, coupled with our clearing projects, is not only good for the environment but also good for our residents and their children, who will hopefully experience some memorable wildlife sightings!

As a reminder, please do not feed wildlife in our community. These critters are healthiest when left to rely on the natural food sources provided in this space. Introducing human food to wildlife will attract rats, coons, and other undesirable animals to the neighborhood.

MCCA Bridges and Bollards: Repair/Restain

MCCA has eleven bridges in the Nature Preserve, Cherry Park, and over the stream that flows between Huckleberry and Cottonwood. Maintenance has pressure washed the bridges and applied a fresh coat of stain on all the wood handrails and supports. The team is also staining wooden bollards that mark some of our trail entries. This project started mid-July and will run through August as weather and the maintenance schedule allow.

Huckleberry Wall: Rebuild – Complete

Our project to replace the Huckleberry wall is finished! The original wall was starting to fail due to a lack of drainage behind the wall and tree roots, both causing the rocks to move. We worked with Currie Construction in early May to remove and replace the rock retaining wall. This was a major project as we needed to use large boulders and heavy equipment and shut down a lane of traffic on Village Green Drive for three days. Following the Right of Way permit we received from the City of Mill Creek, our maintenance crew members, who are certified flaggers, staffed a significant traffic control operation.

The new rock retaining wall uses larger rock and was constructed to ensure water drains through a layer of cobble behind the wall into a perforated pipe and away from the wall. Large footings that reach the glacial till layer were poured for the new brick monument to ensure it stands straight for many years. Recently, the brick wall was rebuilt by Powers Chimney & Masonry. Our electrical vendor, Voltech, returned to run the conduit and rewire the lights. The Huckleberry sign was re-installed on June 27. Maintenance installed the new plantings and bark, and this project is complete.

Mel Silver (Fairway Village I)



A Note About Bears

As bears begin the process of entering their dens for winter, they go through an active period in the fall where they are foraging for food. Avoid storing pet food outside, always keep garbage cans stored away and tightly closed until collection day. Avoid using bird feeders until winter. These can be a major attraction for hungry bears! Clean up fallen fruit and anything else around your home that could attract hungry animals.

Garage Door Reminder

In the month of July, we averaged 28 open garage doors per week. This is 28 opportunities for theft! Please remember to check your garage doors before you go to bed. We are here to help keep the community safe, so we will continue to do our best to catch these occurrences and contact homeowner's as needed, but working together is our best chance of preventing theft. This is another great reason to make sure the office has a current phone number on file so we can reach you in situations like this. Package Pick-ups

For our residents who have requested package pick-ups while away, please know we make every effort to pick-up deliveries as promptly as we can. With only one driver on patrol at a time, checking up to fifty homes in one day, it is impossible to pick up packages for everyone on our list the minute they are delivered. If you have a ring camera or were notified from the sender that a package has been delivered, please call or text Security at 425-328-0035 to let us know and we will pick up your package as soon as possible.

COVENANT COMMITTEE

If you are hoping to avoid attention from the Covenant Committee this season, performing the following tasks on a regular basis will make ongoing yard maintenance manageable.

Remove Weeds

Make sure garden beds are weed free. As a homeowner, it's important to know about noxious weeds like Herb Robert, Mallow, and Vetch. If found in your yard, remove them promptly to prevent their spread! This proactive approach not only protects your yard but also your community. If you need help identifying these weeds and others, visit the <u>Washington State Noxious Weed Control Board's</u> website. Don't forget to pull weeds from driveway and sidewalk cracks and along the front curb.

Lawn Care

If grass is growing into your garden beds, edge the grass for a cleaner look. Here are a couple of how-to videos on different methods of edging your lawn:

Use a plant identification app like <u>PictureThis</u> to help you discover tips and tricks to keeping your shrubs and trees happy!

August and September Checklist

- Finish exterior projects.
- Mulch your beds if you have not done so in a while.
- Dispose of any debris.
- Dethatch/Overseed in September.
- Check window weather stripping and replace it if necessary.
- Clean gutters of debris.
- Schedule chimney cleaning before the winter season.
- Store out of season items that are no longer being used.

A MESSAGE FROM TRAIL AMBASSADORS

Mill Creek Wildlife

It's summer in the great Pacific Northwest and for many of us who live near ponds or other bodies of water, summer evenings are synonymous with the sounds of croaking bullfrogs. But did you know that the American Bullfrog is not a native of Washington State or even the West Coast?

Introduced into Washington during the Great Depression (early 1930s) to provide opportunities for frog hunting, food (frog legs), and stock for frog farms – enterprises that rarely succeeded, <u>Washington State now classi-fies these amphibians an "exotic," invasive species</u>.

The large populations of bullfrogs in the Pacific Northwest have contributed to the decline of native amphibians and reptiles. Adult bullfrogs are "sit and wait" predators, attacking almost any live animal smaller than themselves—insects, frogs, tadpoles, fish, small snakes, turtle hatchlings, newts, salamanders, bats, hummingbirds, and ducklings.

So please remember, under no circumstances should you take/purchase bullfrog tadpoles for your home pond, transfer wild-caught bullfrogs, or in any way encourage them to expand their range. If you are adding plants or



water to a small pond, please make sure you are not also adding bullfrog eggs or tadpoles.

Exterior Lighting Guidelines

Exterior lighting can both improve safety on your property and boost your home's curb appeal. The MCCA recognizes that use of exterior lighting has changed over the years, so we've updated our <u>Rules and Regulations</u> to ensure we have clear guidelines for the ACC to consider when reviewing homeowner exterior light applications. Please read the complete guidelines on the following page. These rules will take affect on January 1, 2025 to give our homeowners time to make any necessary changes or apply as needed.

If you are considering updating or adding exterior lights to your property, please remember to obtain ACC approval prior to installation. This includes all exterior lighting: house, security, landscape, and string/rope lights; the only exception is holiday light installations. Several factors including, but not limited to, angles, distances, landscaping, and house architecture, can cause the same or similar outdoor lighting configurations to appear differently between residential lots;



therefore, the ACC's primary objective will be to ensure that a residential lot's outdoor lighting adheres to the values of the MCCA.

At any time, MCCA may evaluate unduly bright lights that are a nuisance to adjacent homeowners. In applying these lighting restrictions, safety considerations will be balanced against aesthetic/nuisance considerations.

ARCHITECTURAL CONTROL COMMITTEE (CONT.)

Exterior Lighting

House Lights

House light installations must abide by the following rules:

- Lights attached to the house or garage should be no higher than 10 feet above ground level except when used at a second-story entry.
- Light output should not exceed 800 lumens.
- Only clear or frosted bulbs for house lights (except for holiday décor) are allowed.
- All wires must be out of view.
- String lights may not be used as house lights.
- · Flashing or blinking lights are not permitted.
- Sport Court lights must be shielded so as not to shine into neighboring homes.

Security Lights

Security light installations must abide by the following rules:

- Maximum brightness of 1300 lumens.
- Lights must be pointed down or shielded so they do not shine into neighboring homes.
- All wires must be neatly tucked away if not hard-wired.
- Use of motion detectors is required; duration setting cannot exceed 5 minutes.
- Installed no higher than 10 feet above the ground.

Landscape Lights

Lighting designs should be made to prevent landscape lights from shining into neighboring homes. Only clear or frosted lights will be approved. Colored or multi-colored landscape lights are not permitted.

String/Rope Lights

String/rope light installations must abide by the following rules:

- May be installed in the backyard only.
- Must be turned off by 11:00 PM. We encourage residents to use timers.
- Must be clear or frosted. No colored lights are permitted.
- Must be firmly attached to the inside of a structure, such as a gazebo, covered patio, or fence.
- Small clear lights may be used to decorate a small tree (no more than 6 feet tall).
- May NOT be strung between a house, tree, pole, or other structure.
- Are NOT considered lighting for safety or security concerns.
- Flashing or blinking lights are not permitted.
- All cords must be kept in a neat and tidy manner.
- Under-eaves, rigid, white LED lighting is permitted. The colored feature of these lights is
 permitted for holiday displays only.

Holiday Lights

Holiday light displays do not require an application. Residents may start installing winter holiday lights in November but cannot turn them on until Thanksgiving weekend. All winter holiday displays must be removed by January 31. Other holidays during the year may be celebrated with light displays installed two weeks before the holiday and removed two weeks after the holiday.

NOXIOUS WEED COMMITTEE

The NWC has had some large projects the first half of this year! Come August, the committee will be on hiatus until mid-September, the exceptions being NWC volunteers keeping watch over some of our parks and watering of the newer native plants. By August the dry ground makes it difficult to get the roots of the nonnative plants, and the risk of encountering wasps, which were unusually abundant last year, is too great.

Projects included assisting the MCCA Maintenance Team by continuing preparations in the area of the Critter Corridor along Village Green Drive for fall planting, by weeding and spreading wood chips along the path within Huckleberry where multiple Douglas fir trees were removed due to laminated root rot. Most recently the committee has been pruning, weeding and spreading wood chips behind Fairway, along Village Green Drive, another area where multiple Douglas fir trees were removed due to laminated root rot.

Foxglove in Bloom!

People have asked, "What is that? It's so pretty!" Perhaps you have noticed the displays of foxglove along Mill Creek Boulevard and Trillium Boulevard where in the past the Maintenance Team and the NWC have removed large amounts of blackberries. With these areas now cleared of invasive plants and open to more light, foxglove, with only a rosette its first year and its stalk of flowers the second year, has become quite prominent. It will self-seed and then die after the second year; but thanks to rabbits, squirrels and mountain beavers, the seeds are widely dispersed, making the displays of foxglove larger each year! Remember, however, that though foxglove is perfect for hummingbird pollination, it is toxic to animals and can be problematic for people, to include a rash from the fine hairs on the leaves or an adverse reaction from inhaling the pollen. Please admire from afar!

Message from South County Fire

Smoke Alarms Save Lives!

Fire can spread rapidly through your home, leaving you as little as one or two minutes to escape safely once the smoke alarm sounds.

Nationally, three out of five fire deaths happen in homes with either no smoke alarms or smoke alarms that are no longer working. Working smoke alarms give you early warning so you can escape quickly. (NFPA.org)

Safety Tips:

- Install smoke alarms in every room a person sleeps, outside each separate sleeping area (hallway), and on every level of the home, including the basement.
- It is best to use interconnected, hardwired smoke alarms so that when one smoke alarm sounds, they all sound. Battery operated smoke alarms are also a good choice, opt for models with 10-year lithium batteries to eliminate the need for annual battery replacement.
- Test all smoke alarms at least once a month by pressing the test button to be sure the alarm is working. **Replace all smoke alarms when they reach 10 years from the manufacturer's date.** *Applies to both hardwired and battery-operated alarms.*
- A closed door may slow the spread of smoke, heat, and fire, increasing your chance of survival. Once you safely escape, do not re-enter your home for any reason. If you cannot escape, because fire or smoke blocks your path, close your bedroom door, call 9-1-1, and inform them of your location inside the house.

Small Recreational Fires 🥪

Recreational fires are allowed for cooking, ceremony or pleasure purposes.

- Fire should be small. Limit to 3 feet wide by 2 feet high and must be contained (example: fire pit).
- Fires and discarded fire materials must be at least 25 feet away from any structure or combustible material.
- A water source must be readily available (example: charged water hose or a 5-gallon bucket).
- Never leave a fire unattended. Fully extinguish the fire with water to drown all the embers then stir with a shovel.
- Recreational fires may also be banned during countywide burn bans issued by the county fire marshal.

Be a Good Neighbor 🃾

If smoke from your fire bothers your neighbors, you must extinguish the fire immediately.

Irritants in the smoke can be especially dangerous for kids, older adults and those suffering from respiratory issues.

- Call 911 for immediate threat to life or property.
- Call the non-emergency number for issues that are not an immediate threat to life or property 425-407-3999.
- File a complaint with Puget Sound Clean Air Agency at 800-552-3565.

Dangerous Outdoor Burning 🔀

LARGE OUTDOOR FIRES ARE PROHIBTED YEAR-ROUND

Outdoor burning is prohibited at all times in the South County Fire service area including <u>unincorporated</u> <u>communities</u> in Snohomish County starting in south Everett and extending to the urban growth areas through to the county line. South County Fire also serves the cities of Mill Creek, Brier, Edmonds, Lynnwood, and Mountlake Terrace. Burn bans and regulations include:

- Burning debris, such as yard waste and scrap wood, is not allowed.
- Burning garbage is not allowed.
- Fireworks discharge is not allowed and is banned year-round.


MILL CREEK LIBRARY
